



CIIS 2019 Inauguration Ceremony

The inauguration ceremony was graced by the presence of who's who of the policing fraternity & policy experts such as Mr. V. K. Singh, Mr. Sanjay Rana, Mr. K. T. Vaiphei, Mr. Michael Steven Juma, Mr. Vytenis Benetis, Mr. Manohar Katoch & Mr. Sanjay Sharma.

The inauguration ceremony commenced with the welcome note of Mr. K. T. Vaiphei, Director of Madhya Pradesh Police Academy. During his addressal, he focused on the emergence of cybercrime & growing concerns on the safety of women & children. He also stated that seminars such as CIIS are linchpin to a cybercrime free state and country.



While addressing the participants, CIIS' chief guest, Mr. V. K. Singh stated that the inadequacy of law enforcement in handling cybercrime, propels them to seek help from experts of the cyber and information technology domain.

Mr. Sanjay Rana, Special Director General of Police, Training, also addressed the participants during the ceremony. He mentioned that the biggest challenge in cyber communication age is that the cyber space is boundaryless, which makes the investigations very difficult.

Mr. Manohar Katoch from CIIS's Knowledge Partner ClearTrail Technologies, mentioned that the answers to the problems investigators face in cybercrime investigations will be available only through ac cessing the criminal data & analyzing it effectively.

Day 1: Thursday, 12 Sep 2019

Panel Discussion on "Concerns related to online abuse of women & children"

The first session of CIIS 2019 was a panel discussion on "Concerns related to online abuse of women & children". As panelists, Mr. Purshottam Sharma (Sp. DG-Cyber), Dr. Ruchi Sinha (TISS) & Mr. Michael Steven Juma (UNICEF) took the participants through a detailed discussion on detection, prevention & control of online abuse of women & children. Also, Mr. Juma shared about the efforts made by UNICEF specifically in the addressal of this issue.

Frauds & Secure Use of UPI Related Payments

In the next session, the participants interacted with Mr. Bharat Panchal from the National Payments Corporation of India, who conducted a highly informative session on Frauds & Secure Use of UPI Related Payments.

Live Collection of Social Media Data (OSINT) & Visual Analytics

Post lunch, the audience was taken by storm when the experts from ClearTrail Technologies demonstrated the Live Collection of Social Media Data (OSINT) & Visual Analytics. When the experts showcased insights generated from the encrypted messaging app WhatsApp, the audience was particularly enticed.

Identification & Collection of Digital Evidence




He also shared his thoughts on the future of policing & how it is not just important to arrest & convict a criminal, but also prosecute him in the court of law.

Ms. Neha Bainsla from Soft Clicks Foundation delivered the closing note for CIIS 2019.


